TRACT #1: ALL THAT CERTAIN piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina on the northern side of Sulphur Springs Road being designated as Lot 24 on a map of Highview Acres recorded in Plat Book 0, Page 123 of the Greenville County RMC Office and having, according to a recent survey entitled "Property of Belham Realty, Inc." dated February 13, 1980 by Dalton & Neves Co., Engineers, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of Sulphur Springs Road which iron pin is located 144.7 feet west of the intersection of said Sulphur Springs Road with Courtland Drive at the joint front corner of Lots 23 and 24 and running thence with the northern side of Sulphur Springs Road S. 87-00 W. 150 feet to an iron pin in the center of a Duke Power Company right of way at the joint front corner of Lots 24 and 25; thence with the common line of said lots, N. 3-07 W. 494.5 feet to an iron pin; thence N. 87-00 E. 190 feet to an iron pin at the joint rear corner of Lots 23 and 24; thence with the common line of said lots, S. 1-31 W. 496.0 feet to an iron pin on the northern side of Sulphur Springs Road, the point of beginning.
