Constructing curb and gutter around radius of the intersection of Old Airport Road (Woods Crossing Road) and Timmons Drive.

Together with the right of ingress and egress for the purpose of inspecting and maintaining the same.

Said property is described as follows: Located in the County of Greenville along existing Old Airport Road (Woods Crossing Road) and being all of Area C as shown on attached survey and being more particularly described as follows:
