on the referred to plat.

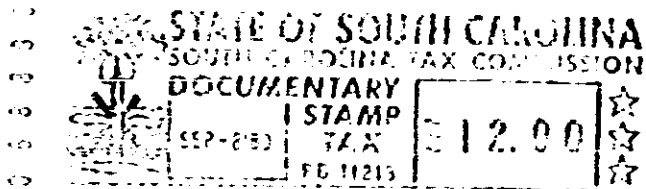
