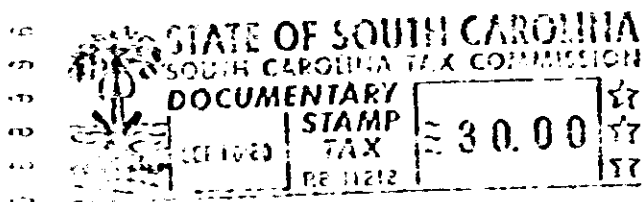
ALL that certain piece, parcel, or lot of land with the buildings and improvements thereon, lying and being on the northwesterly side of Sugar Creek Road, near the City of Greenville, South Carolina, being known and designated as Lot No. 53 on plat entitled "Map 1, Section 2, Sugar Creek," as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 7-C at Page 68 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Sugar Creek Road, said pin being the joint front corner of Lots 53 and 54 and running thence with the common line of said lots N. 57-26 W., 145 feet to an iron pin, the joint rear corner of Lots 53 and 54; thence N. 32-34 E., 125 feet to an iron pin, the joint rear corner of Lots 52 and 53; thence with the common line of said lots S. 57-26 E., 145 feet to an iron pin on the northwesterly side of Sugar Creek Road; thence with the northwesterly side of Sugar Creek Road S. 32-34 W., 125 feet to an iron pin, the point of beginning.
