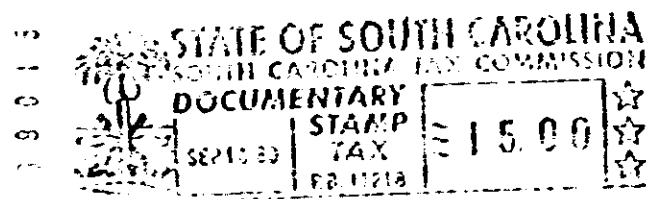
in consideration of SEVEN THOUSAND THREE HUNDRED AND NO/00 ----- Dollars,

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and being shown and designated as Lot 25 on the plat of Dellbrook Estates, recorded in the RMC Office of Greenville County in Plat Book 4N on page 40, and by a more recent plat of William B. Arrington and Mary J.
