All that certain lot, piece, parcel or lot of land near the Town of Greer, Chuck Springs Township, County and State aforesaid, known and designated as Lot No. 2, according to a survey and plat of property of the B.S. Robertson Estate made by H.S. Brockman Surveyor, October 17, 1945, said plat being of record in the R.M.C. Office for Greenville County in Plat Book "Q", page 101, and having the following metes and bounds and courses and distances as shown by said plat, to-wit:

BEGINNING at the Northeast corner of said lot, corner of Lot No. 1, and in southern line of driveway leading to colored cemetery, and running thence along the southern line of said driveway N72 - 33W for 141 feet; thence S16 - 15W for 194.8 feet to corner of M.H.
