This Power of Attorney shall not be affected by physical disability or mental incompetency of the said principal, Mina Odom, which renders the principal incapable of managing her own estate showing the intent of the principal, Mina Odom, that the authority conferred shall be exercisable notwithstanding her physical disability or mental incompetency.
