the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto SOUTHERN BANK & TRUST COMPANY, TRUSTEE under agreement with H. Caldwell Harper, dated December 29, 1971, its successors and assigns, forever:

AN UNDIVIDED ONE-HALF INTEREST IN AND TO

ALL that certain lot of land lying on the southern side of Roper Mountain Road, in Greenville County, South Carolina, being designated as Lot 32 on a plat of "Sheet No. 1 of Huntington", prepared by Piedmont Engineers & Architects, recorded in Plat Book WWV at page 23B (sometimes referred to as Plat Book WWV at page 23) and being further described according to such plat as follows:
