

BEGINNING at an iron pin at the corner of property of C. Douglas Wilson & Co., and the property containing 2.45 acres, more or less, reserved by Beulah Garrison and running thence along the Garrison property N. 10 W., 248.2 feet to an iron pin and post; thence S. 58 W., 253.7 feet to an iron pin on the Willis property; thence N. 26-30 E., 1044.3 feet to an iron pin in a branch; thence following the branch as the line, S. 57-30 E., 136.6 feet to a point; thence S. 39-45 E., 239.6 feet to a point; thence N. 76 E., 403.9 feet to a point in said branch, at a black gum at the corner of the Willis property and the Jule Anderson property; thence along the Anderson property, S. 23-45 E., 809.2 feet to an iron pin at the corner of property of C.
