KNOW ALL MEN BY THESE PRESENTS, that I (William C. Davis)

in consideration of the sum of One (\$1.00) and the property \_\_\_\_\_ DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said James D. Shockley and Eva V. Shockley, their heirs and assigns, forever:

ALL MY RIGHT, TITLE AND INTEREST, IN AND TO THE FOLLOWING:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the south side of Riverview Circle, in Greenville Township, near the City of Greenville, shown as Lots 6 and 7 on plat of Map. No. 2, of Riverdale Subdivision, made by Dalton and Neves, Engineers, June 1953, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "M" at page 19, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Riverview Circle at the joint front corner of Lots 5 and 6, and running thence with the line of Lot 5, South 9-21 West 264 feet to an iron pin at the high water mark of the Saluda River; thence with the high water mark of the Saluda River, North 72-12 East 198.5 feet to an iron pin on the highwater mark of the Saluda River, North 48-41 East 141.1 feet to an iron pin at the joint rear corner of Lots 7 and 8; thence with the joint line of said lots North 32-34 West 186 feet to an iron pin on the south side of Riverview Circle; thence with Riverview Circle South 54-0 West 33.7 feet to an iron pin; thence with the curve of Riverview Circle (the chord being South 62-34 West 45.3 feet) to an iron pin at the joint front line of Lots 6 and 7; thence continuing with the curve of Riverview (the chord being South 85-52 West 80 feet) the to the point of BEGINNING."
