the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Stanley A. C. Masters, his heirs and assigns, forever:

ALL that certain piece, parcel or lot of land in Fairview Township, County of Greenville, State of South Carolina, being a part of the J. Furman Richardson Estate and containing 1.05 acres, more or less, and according to a survey by J. L. Montgomery, III, RLS, dated June, 1977, having the following metes and bounds, to-wit:

BEGINNING at an iron pin approximately 389 feet from the intersection of Hospital Drive and SC Highway No. 14, on the eastern side of Hospital Drive and running thence S. 62-41 E., 247.27 feet to an iron pin; thence N. 00-10 E., 148.81 feet to an iron pin; thence N. 00-05 E., 86.6 feet to an iron pin; thence turning and running N. 68-20 W., 208.9 feet to an iron pin on the Eastern side of Hospital Drive; thence with said Drive, S. 7-00 W., 184.85 feet to an iron pin; thence continuing with said Drive, S. 12-54 W., 15.96 feet to an iron pin, the point of beginning.
