As a further part of the consideration for this deed, the grantors hereby assign, transfer and set over unto the grantee all their right, title and interest in and to any escrow deposits maintained by the mortgagor in connection with the mortgage herein referred to above.

The grantees agree to pay Greenville property taxes for the year 1991 and all subsequent years.
