granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto PERRY E. BURTON, his
Heirs and Assigns forever, all my right, title and interest, being a one-half interest
of, in, and to the following described property:

All those certain pieces, parcels or lots of land, with the buildings and improvements
thereon, lying and being on the southerly side of Frankfort Court, in the town of
Simpsonville, County of Greenville, State of South Carolina, being known and designated
as Lot No. 11 and a portion of Lot No. 12, on plat of Section No. 1 of Penderhorn, as
recorded in the RNC Office for Greenville County, South Carolina, in Plat Book 4-X,
Page 95, and having, according to a more recent survey prepared for Perry E. Burton and
Eugenia H. Burton, prepared by Clarkson Surveying, dated October 17, 1979, and recorded
in the RNC Office for Greenville County in Plat Book 7-X at Page 59, the following metes
and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Frankfort Court, said pin being the
joint front corner of Lots 11 and 12 and running thence with the southerly side of
Frankfort Court on a curve, the chord of which is N. 31-57 E., 34.0 feet to an iron
pin on the southerly side of Frankfort; thence with the southerly side of Frankfort
Court S. 31-30 E., 93 feet to an iron pin; thence S. 61-14 E., 150 feet to an iron pin;
thence N. 35-59 W., 68.75 feet to an iron pin; thence N. 53-17 W., 33.2 feet to an iron
pin, the joint rear corner of Lots 11 and 12; thence with the common line of said lots,
N. 57-34 E., 136.11 feet to an iron pin, the point of beginning.

This being the same property conveyed to Grantor herein by deed of the American Service

County, South Carolina, in Mortgage Book 1436, Page 633, together with all and singular the rights, incidents, hereditaments and appurtenances to said premises belonging or in any wise incident or ap-
pertaining to have had and to hold all and singular the premises before mentioned unto the grantor(s), and the grantor(s) heirs or successors and
assigns forever. And, the grantor(s) do(es) hereby bind the grantor(s) and the grantor(s) heirs or successors, executors and administrators
to warrant and forever defend all and singular said premises unto the grantor(s) and the grantor(s) heirs or successors and against every per-
son whosoever lawfully claiming or to claim the same or any part thereof.
