forever:

ALL that certain piece, parcel, or tract of land lying, being and situate in the County and State aforesaid, Fairview Township, and within the corporate limits of the Town of Fountain Inn, on the North side of South Carolina Highway 418 (Fairview Street), containing two (2) acres according to a plat and survey dated February 18, 1981, by John E. Woods, R.L.S., and having according to this Plat the following rates and bounds, to-wit:

BEGINNING at an iron pin in the Northern edge of said Hwy. 418, joint front corner with D. E. Patterson, said pin measuring a distance of 300 feet, more or less, West of intersection of Hwy. 418 and Old Fairview Road, and running with Patterson line N. 47-33 E. 277.2 feet to an iron pin, corner with J.
