unto SETH W. SCRUGGS, his heirs and assigns forever:

ALL that piece, parcel or lot of land lying and being in Greenville County, State of South Carolina, near Ebenezer Baptist Church and being a portion of a 16.82 acre tract shown on survey for T. E.
