ALL that certain parcel or tract of land in O'Neal Township of Greenville County, State of South Carolina, located about three miles north of the City of Greer, near the Old Ansel School Place, bounded on the north by lands now or formerly owned by Few, on the East by Calvin Parris, Manley Mason, Leopard and possibly others, on the south and west by lands of P.D. Bridwell, containing by estimation, 10 acres, more or less, and being all of the remaining portion of that tract of land conveyed to Amanda Southern Hargrove by E.E. Southern, Administrator with the Will Annexed of the Estate of W.G. Southern by deed recorded in Volume 197, page 42, R.M.C. Office for Greenville County.

THIS being the same tract of land as conveyed to Pearl Annie Foster, Nancy Jane Hart, and Eugene Southern by deed of Nellie M. Southern, dated October 2, 1970, duly recorded in the Office of R.M.C. for Greenville County in Deed Vol. 900 at page 433; and, further, a one-third interest having been conveyed to the Grantee herein heretofore which belonged to Eugene Southern. This property is subject to a life-estate of Amanda Southern.
