James F. Elrod and Martha A. Elrod, their heirs and assigns, forever:

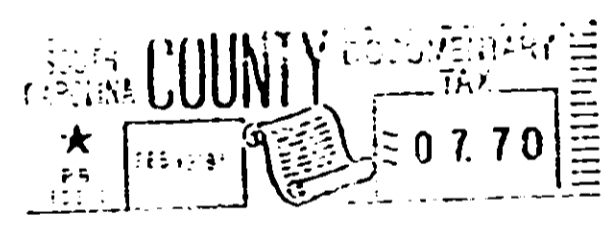
