BEGINNING at an iron pin on the northeastern side of Industrial Drive 250 feet North from property of Sullivan Hardware Company, and running thence along the northeast side of Industrial Drive, N 37-10 W 150 feet to an iron pin; thence N 52-50 E 250 feet to an iron pin on the right-of-way for the C. & W.C. RR.; thence along said right-of-way, S 37-10 E 150 feet to an iron pin; thence S 52-50 W 250 feet to the point of beginning.

RR. right of way; thence with said right-of-way, S 37-10 E 150 feet to an iron pin; thence S 52-50 W 250 feet to the beginning corner.
