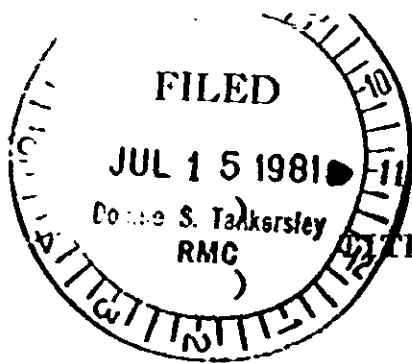


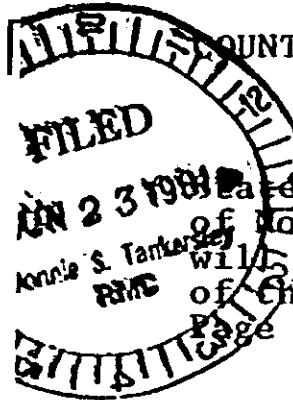

WHEREAS, Heyward Edison Duncan, late of the County and
aforesaid, purchased a lot and building on the southeast side
of North Main Street, in the City of Greer, South Carolina, as
will more fully appear by reference to deed recorded in the Office
of the R.M.C. for Greenville County in Deed Book 281 at
Page 116; and

WHEREAS, The said Heyward Edison Duncan died testate on the
16th. day of January, 1967, leaving of force and effect his Last
Will and Testament dated January 13, 1966, duly admitted to pro-
bate in the Office of the Probate Court for Greenville County,
South Carolina, in Apartment 972, File 13; and

WHEREAS, By the term of said Will, the Citizens and Southern
National Bank of South Carolina, Greenville, S. C., and Thelma

the 10th. day of June, 1981; and

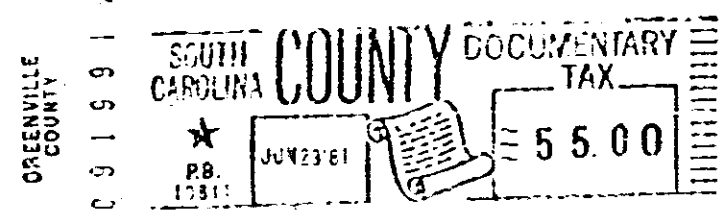
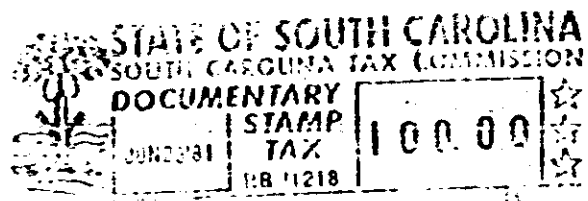
WHEREAS, The said Heyward Edison Duncan by his Will did
