KNOW ALL MEN BY THESE PRESENTS, that the Will of Francis Lee Shackelford

A Corporation chartered under the laws of the State of South Carolina and having a principal place of business at Greenville, State of South Carolina, in consideration of final distribution of assets of the Trust under the Will of Francis Lee Shackelford

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto JOHN COOPER SHACKELFORD and FRANCIS LEE SHACKELFORD, JR., a 5.19 per cent interest in and to:

ALL that certain piece, parcel or lot of land, situate, lying and being on the southern side of East Washington Street, being described according to a plat of property of R.R. Stokes prepared by R. E. Dalton, October 1949, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a point on the southern side of East Washington Street, which point is 25 feet in a northwesterly direction from the southwestern corner from the intersection of East Washington Street and Irvine Street, and running thence along the southern side of East Washington Street N. 70-54 W. 71.35 feet to an iron pin; thence S. 20-32 W. 173 feet to an iron pin; thence S. 70-54 E. 96.6 feet to an iron pin on the western side of Irvine Street; thence along the western side of Irvine Street N. 20-27 E. 73 feet to an iron pin on the northern side of a ten-foot alley; thence along the northern side of said ten-foot alley, N. 70-54 W. 25 feet to an iron pin; thence N. 20-27 E. 100 feet to the beginning corner.

The above conveyance is subject to the right in and to a ten-foot alley created by deed which is recorded in Deed Book 212, Page 59, dated June 29, 1939.

The purpose of this deed is to correct the interest conveyed by deed of Bankers Trust of South Carolina, as Trustee under the Will of Francis Lee Shackelford to John Cooper Shackelford and Francis Lee Shackelford, Jr. dated October 31, 1980 and recorded in the RMC Office for Greenville County in Deed Book 1136 at Page 534 from .0519 per cent interest to 5.19 per cent interest.

And, the grantor does hereby bind itself and its successors to warrant and forever defend all and singular said premises unto the grantee(s) and the grantee(s)' heirs or successors and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
