AFFIDAVIT

PERSONALLY appeared before me, the undersigned, W. Daniel Yarborough, Jr., who being duly sworn first, did state as follows:

I am an attorney practicing law in Greenville, South Carolina. Since January 1, 1981, I am also the Vice President and General Manager of Development for Danco, Inc. Prior to such employment with Danco, Inc. I served as the attorney for said company. In the above stated capacities I am very familiar with the facts surrounding the dealing between Danco, Inc. and one Lurton E. Lipscomb pertaining to Lot 128, Forrester Woods, Section 7, Plat Book 5-P at pages 21 and 22 of the EMC Office for Greenville County. This affidavit is prepared for the purpose of inducing Chicago Title Insurance Company to issue an Owner's and Mortgagee title insurance policy on the property in question to a party or parties who currently have contracted to purchase said property.

On August 17, 1978, Danco, Inc. contracted to sell to Lurton E. Lipscomb, Lot 128, Forrester Woods, Section 7. Attached hereto is a true copy of said contract. Said contract called for sale by way of Bond For Title which would be fully performed on or before August 17, 1979.

A Bond For Title was executed between Danco, Inc. and Lurton E. Lipscomb, dated October 13, 1978 and recorded in the EMC Office for Greenville County on October 19, 1978 in Deed Book 1090 at Page 205. The original recorded Bond For Title is attached hereto. Danco, Inc. has performed every one of its duties with regard to the Bond For Title. During the month of June 1979, Lurton E. Lipscomb defaulted on his obligation under the Bond For Title to pay the monthly payments as called for in the Bond. I personally notified Mr. Lipscomb of his default by letter. Mr. Lipscomb did not cure his default, and in fact, was not heard from at all. Danco, Inc. instituted suit against Mr. Lipscomb on June 1, 1979 for his failure to pay for certain items over allowance which had been installed in his house. I am informed and believe that he left his residence on the date of service in June of 1979, and to my knowledge he has not returned to South Carolina. A default judgement regarding his failure to pay for said overages was obtained in November, 1979.

The undersigned, as attorney for Danco, Inc. has attempted and failed to locate Lurton E. Lipscomb. It is believed that he left this state on or about June 1, 1977. Danco, Inc. has met all requirements stated in the Bond For Title aforementioned with regard to notifying Mr. Lipscomb of his default in the terms of the Bond For Title, and further, Danco, Inc. has met every condition stated in the Bond For Title regarding the rights of a defaulting party.
