FLOYD A. ANDERSON AND MARTHA L. ANDERSON, THEIR HEIRS AND ASSIGNS FOREVER:

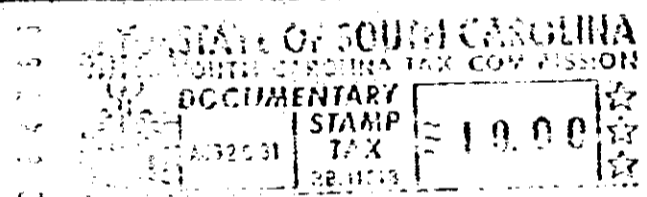
