along Powderhorn Road, Appomattox Drive, Harrisburg Drive, Harper's Ferry Ct.,  
and Richmond Ct., County of Greenville, State of South Carolina including ap-  
proximately 1,380 feet more or less of 8" D.I. Pipe, 520 feet more or less of  
6" D.I. Pipe, 2,070 feet more or less of 2" Galv. Pipe, one 8" valve, eight  
6" valves, ten 2" valves and five Fire Hydrants as is shown on a drawing en-  
titled "American Service Corporation of S.C. to Commissioners of Public Works  
of the City of Greenville, S.C." dated October 13, 1981, attached hereto and  
made a part of this conveyance.
