in consideration of One Dollar, love and affection Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto ROSE MOORE TOMLIN an undivided one-twelfth interest in and to:

All that piece, parcel or lot of land in Cleveland Township, Greenville County, State of South Carolina, bounded:

- (a) on the south and southeast by the center line of Old Springfield Road and the center line of the Geer Highway (US 276);
- (b) on the north and northeast by property formerly of Alice Legrand Mills (which is shown on a plat entitled "Plat of property of Alice Mills, Cleveland Twp., Greenville, Co., S.C., made by Terry Dill, March 31, 1959) and by the North Carolina State line, and
- (c) on the west and southwest by the North Carolina State line and by property now or formerly belonging to R.L. Vaughn (which is shown on a plat recorded in the R.M.C. Office for Greenville, S.C. in Plat Book K at page 129).

The line along the southwestern boundary of this tract, where it joins the land now or formerly of Vaughn, runs from the center line of the Old Springfield Road, N. 39-30W. 2030 ft., to a stone on the North Carolina Line.

This property contains about 130 acres. The property adjoins property sold by the grantor to the S.C. Department of Parks, Recreation and Tourism. This deed, a companion deed to James P. Moore, Jr., and a deed to the grantee in Book 1048, page 253, divest the grantor of his original half interest.

This property is subject to an agreement between James P. and Otis P. Moore, dated December 10, 1967, limiting the right of judicial partition through December 31, 1986.
