BEGINNING at an iron pin on the West side of North Main Street approximately 60 feet Southward from the South side of College Street, and said pin being on the Southeast corner of a lot now or formerly belonging to The Realty Company of Greenville, S.C., and running thence along said lot N. 72 degrees W. 130 feet to a stake on a alley; thence with the said alley, S. 18 degrees W. 20 feet to a stake on the corner of a lot conveyed by the late Alexander MacBeth, Trustee, to W.A.
