If Lessee purchases the property, then contemporaneously with the conveyance of the property to Lessee this lease shall become null and void, without further notice, and Lessee shall thereupon be released and discharged from all further rentals and other obligations on the part of the Lessee to be paid, kept and performed.

17. The payments made and to be made hereunder by Lessee to Lessor shall be considered sufficient consideration for any and all options herein granted by Lessor to Lessee.

18. Any notice under or inquiries regarding this lease shall be delivered to Lessor at Lyyy, Whitehoese Ryon and to Lessee at 35 East Wacker Drive, Chicago, Illinois, or such other address as the parties may from time to time designate in writing. Notice may be given by registered mail or certified mail, and in such event the date of service shall be the date on which the notice is deposited in a United States post office properly stamped and addressed.
