BEGINNING at a spike near the center line of Griffin Drive, at the corner of the premises herein described and property now or formerly of Grace Moon Griffin, and running thence with the line of property now or formerly of Grace Moon Griffin, the following courses and distances: S. 6-29 E. 245.21 feet to an iron pin; thence S. 83-31 W. 124.74 feet to an iron pin; thence S. 83-28 W. 99.72 feet to an iron pin at the corner of property now or formerly of J. W.
