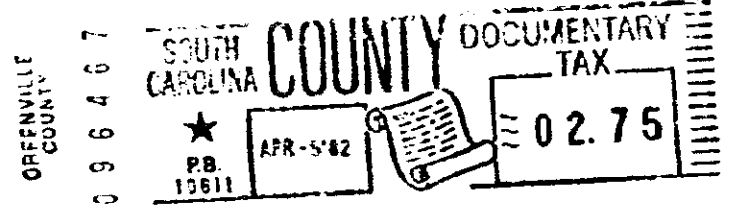
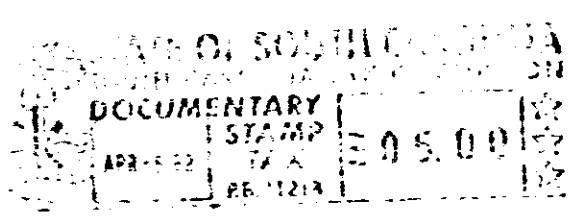
in consideration of Two Thousand Three Hundred Dollars and no/100's (\$2,300.00)----- Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Frances Hunter and Dewey Hunter, their heirs and assigns forever,

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina situate on the East side of Beatrice Street, in Greenville Township, and having according to plat thereof made by R. E. Dalton, December 13, 1946, the following metes and bounds, to- wit:

BEGINNING at a stake on the East side of Beatrice Street, said stake being 62 feet South From the Southeast corner of the intersection of Beatrice Street and Frances Avenue, and running thence with the East side of Beatrice Street, S. 21-55 E. 60 feet to iron pin; thence N. 67-48 E. 240.6 feet to an iron pin; thence N. 21-55 W. 60 feet to iron pin; thence S. 67-48 W. 240.6 feet to a stake on the East side of Beatrice Street, the point of beginning. 14 (235) 228-12-2

This is the same property conveyed to Mrs. Ruth Moore by Deed of James Leonard Moore recorded in Deed Book 505 at Page 340 in the R. M. C. Office for Greenville County. Mrs. Ruth Moore died testate on November 7, 1980, leaving the Church of Jesus Christ of Latter Day Saints, Greenville Ward ten (10%) percent of her estate after expenses, debts, and funeral expenses have been paid, and leaving the following named persons the remaining interest in her estate: Rochelle Medlock, Virginia West, James, Joyce, Charlie, Walter, David and Henry Moore, and Violet Frye. The estate of Mrs. Ruth Moore was probated in Dept. 1634 at File 10 in the Probate Court for Greenville County, State of South Carolina.
