The Grantor does hereby grant, bargain, sell and release unto the Grantee the right, privilege and easement to enter upon and exit from certain real property of the Grantor located at the southwestern intersection of Rushmore Drive and Edwards Road in Greenville County, South Carolina, as generally represented on that certain drawing entitled "Easement, Liberty Life Insurance Co. to Commissioners of Public Works of the City of Greenville, S. C." dated January 12, 1982, attached hereto and made a part hereof, for the purpose of reading, operating, maintaining, replacing and adding to the water meters and other appurtenances thereto located on the said property of the Grantor.

It is understood and agreed that the water mains located in and serving Glenbrooke Townhomes and being part of the property of the Grantor, shall be and do remain the property of the Grantor and the Grantor shall be responsible for the maintenance thereof.
