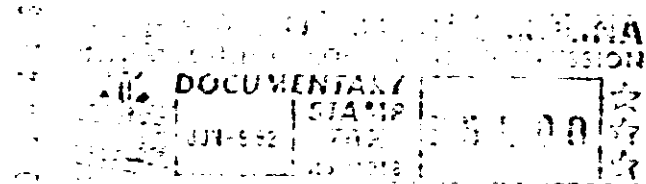
KNOW ALL MEN BY THESE PRESENTS, that Parkins Knoll, Inc.

the receipt of which is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and
release unto Williams Street Development Corp., its successors and assigns, forever:

ALL that certain piece, parcel or lot of land, together with all improvements thereon or hereafter to be constructed thereon, situate, lying and being on the Eastern side of Parkins Mill Road, in the City of Greenville, County of Greenville, State of South Carolina, being shown and designated as Lot No. One (1) on plat of PARKINS KNOLL, prepared by Piedmont Engineers & Architects, Surveyors, dated May 18, 1973, and recorded in the RMC Office for Greenville County, S. C. in Plat Book 5-D, at Page 34, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Eastern side of Parkins Mill Road, at the joint front corner of Lots Nos. 1 and 2, and running thence with the joint line of said lots, N. 87-37 W. 173.19 feet to an iron pin in the line of Lot No. 3; thence with the line of Lot No. 3, N. 00-41 E. 85.0 feet to an iron pin at the joint rear corner of Lots Nos. 3 and 1; thence with the line of Lot No. 1, N. 55-47 E. 242.9 feet to an iron pin on the Eastern side of Parkins Mill Road; thence with the Eastern side of Parkins Mill Road, the following courses and distances: S. 8-55 W. 96.7 feet to an iron pin; thence S. 6-33 W. 99.0 feet to an iron pin; thence S. 4-10 W. 35.0 feet to an iron pin, the point of beginning. 15(500) M15.7-1-2
