KNOW ALL MEN BY THESE PRESENTS, that PINE KNOLL INVESTORS, A GENERAL PARTNERSHIP,

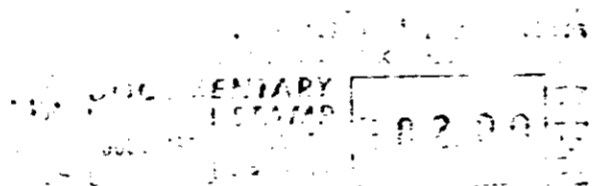
in consideration of Forty Thousand Nine Hundred Fifty and No/100 (\$40,950.00)----- Dollars,
