

BEGINNING at an iron pin on the easterly side of Ladyslipper Lane, said pin being the joint front corner of Lots 573 and 574, and running thence with the common line of said lots S. 79-20 E. 148 feet to an iron pin on the joint rear corner of lots 573 and 574; thence S. 28-07-50 W. 162.10 feet to an iron pin, joint rear corner of Lots 572 and 573: thence with the common line of said lots N. 34-40 W. 160 feet to an iron pin on the easterly side of Ladyslipper Lane; thence with the easterly side of Ladyslipper Lane on a curve, the chord of which is N. 33-00 E. 38 feet to an iron pin, the point of 11(195) 538.17-1-65 beginning.
