Walker hereafter referred to as Grantee, at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the said Grantee, her heirs and assigns, forever, all the right, title and interest of the undersigned in and to the below described property.

ALL that piece, parcel or lot of land situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, shown on a survey for Halter-Walker, dated August 6, 1982, prepared by James R. Freeland, designated as Tract "A" on said plat and containing 4,933 square feet, and having according to said plat the following metes and bounds:

BEGINNING at an old iron pin at joint corner with Tract "B" as shown on said plat; thence running N. 33-18 E. 117.8 feet to an old iron pin; thence turning and running S. 53-20 E. 42.8 feet to a point; thence turning and running along line of other property of Grantor S. 27-56 W. 90.8 feet to a point; thence turning and running along common line with Tract "B" N. 82-33 W. 57.0 feet to an old iron pin, the point of beginning.
