

CONVEYANCE FOUR:

ALL that piece, parcel or lot of land, with all improvements thereon, situate, lying and being in the State of South Carolina, County of Greenville in the Town of West Greenville, bearing the street number 22, described as Norwood Land in Plat Book A, at Page 133, said lot having a frontage of 50 feet on Vance Street and a depth of 150 feet.

This is the same as that conveyed to G. Taft Joseph by Frank P. McGowan, Jr., as Master in Equity in and for Greenville County dated August 7, 1975 and recorded August 7, 1975 in Vol. 1022 at page 425 aforesaid records.

CONVEYANCE FIVE:

ALL that piece, parcel or lot of land in Greenville County, State of South Carolina, situate lying and being on the northern side of Julian Street in the County and State aforesaid, being shown as Lot No. 28 on a plat of Queen Heights made by N. O. McDowell, Jr., and J. P. Moore, November, 1944, recorded in Plat Book O, Page 87, in the RMC Office for Greenville County and having, according to said plat the metes and bounds thereon.

This being the same as that conveyed to G. Taft Joseph by deed of William Michael Joseph dated January 10, 1979 and recorded January 10, 1979 in Vol. 1095 at page 151 aforesaid records.

CONVEYANCE SIX:

ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated on the east side of McCall Street and having the following metes and bounds, to-wit:

BEGINNING at the corner of McCall Street and an alley and running thence with said McCall Street S. 20 E. 39 feet and 3 inches to an iron pin, corner of lot formerly owned by Mrs. M. W. Hightower; thence with her line N. 70 E. 175 feet to a 14 foot alley; thence with said alley N. 20 W. 39 feet 3 inches to the line of the alley first mentioned; thence with said alley S. 70 W. 175 feet to the beginning corner, and being the northern portion of Lot No. 6 as shown on plat recorded in the RMC Office for Greenville County in Plat Book A, page d158.
