All that certain piece, parcel or tract of land located in the State of South Carolina, County of Greenville, containing 0.006 acres, more or less, as shown on a plat of same made by C.O. Riddle, RLS, dated October 28, 1982, said plat being recorded herewith, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point in a dirt road, known as Old McKinney Road, said point being approximately 355.16 feet from Cooper Lake Road, and running thence S. 41-00 W., 26.0 feet to the center line of a creek; thence turning and running with the meanderings of the creek (center line of the creek is the property line) N. 49-00 W., 10.0 feet; thence turning and running with the line of other property of the grantors herein N. 41-00 E., 23.84 feet to an iron pin in the dirt road; thence turning and running S. 61-10 E., 10.23 feet to an iron pin in the dirt road, said pin being the point of beginning.
