ALL that piece, parcel or lot of land, together with all buildings and improvements thereon, situate, lying and being on the northwestern side of the Standing Springs Road in Austin Township, Greenville County, South Carolina, 3-1/2 miles south of Mauldin, being a portion of the J. C. LESLEY PROPERTY and being shown on a plat of the PROPERTY OF ALBERT J. SHELTON made by T.H. Walker, Jr., Surveyor, dated September 10, 1966, recorded in Plat Book 6-N at Page 8, as having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of the Standing Springs Road at the corner of property now owned by Sherwood Chevrolet, Inc. and running thence along the line of said property, N. 56-30 W., 200 feet to an iron pin; thence continuing along the line of property owned by Sherwood Chevrolet, Inc., S. 33-36 W., 125 feet to an iron pin on the line of property now or formerly owned by P. G. Jones; thence with the line of said property, S. 56-30 E., 200 feet to an iron pin on Standing Springs Road; thence with the northwestern side of the right of way of Standing Springs Road, N. 33-36 E., 125 feet to the point of BEGINNING.
