GARY B. TURNER & PATRICIA O. TURNER, their heirs and assigns forever;

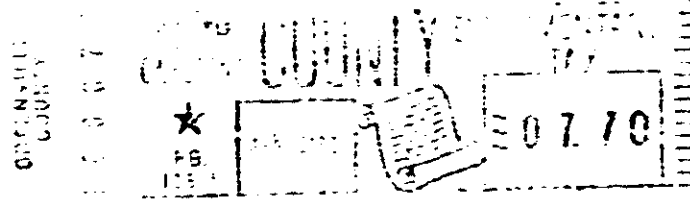
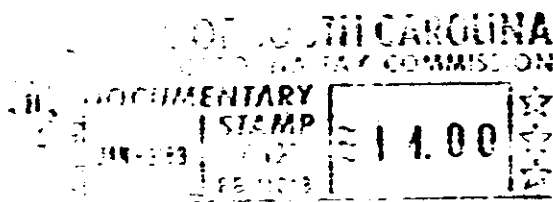
