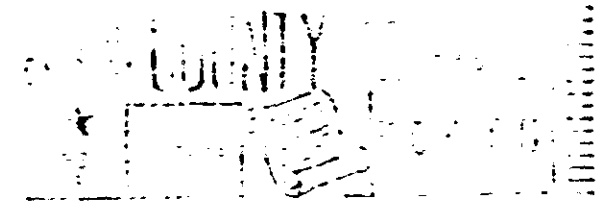
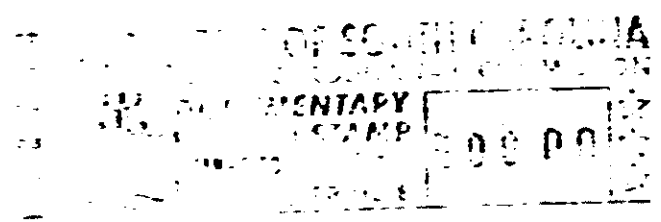
ALL that certain lot of land with improvements thereon situate, lying and being
