and release unto SARAH L. LYNN, her heirs and assigns, forever,

ALL that certain piece, parcel or lot of land in Greenville County, South Carolina, in O'Neal Township on the Southwest side of the Old Buncombe Road, and having, according to a plat thereof made by W. A. Hester, Surveyor, November 10, 1922, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of the Old Buncombe Road, corner of property of J. C. Braeley, and running thence along the line Braeley property S. 36 $\frac{1}{2}$ W. 46.16 chains to an iron pin in branch in line of property of Connie Andrie; thence along the branch as a line in a northwesterly direction 11.10 chains to a stake in line of property of R. H.
