Jonathan W. Brush, his heirs and assigns forever;

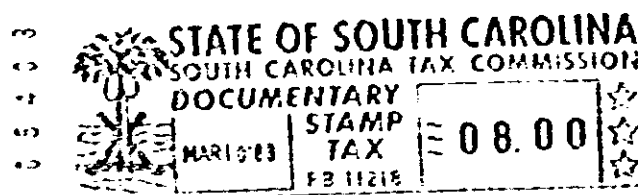
