William Ancrum Floyd died testate on December 25, 1946, and by his Last Will and Testament dated January 16, 1937, filed in Apartment 523, Package 11 in the Office of the Judge of Probate for Greenville County, the said William Ancrum Floyd appointed the First National Bank of Greenville as Executor and Trustee of his Last Will and Testament.
