to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto COTHRAN & DARBY BUILDERS, INC., Its Successors and Assigns, Forever:

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the easterly side of Cherrywood Trail, near the City of Greenville, South Carolina, being known and designated as Lot No. 562 on plat entitled "Map 4, Section 2, Sugar Creek", as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 8-P at Page 62, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Cherrywood Trail, said pin being the joint front corner of Lots 561 and 562, and running thence with the common line of said lots N. 89-59-07 E. 156.63 feet to an iron pin at the joint rear corner of Lots 561 and 562; thence N. 24-04-24 W. 85.32 feet to an iron pin at the joint rear corner of Lots 562 and 563; thence with the common line of said lots S. 77-29-02 W. 124.03 feet to an iron pin on the easterly side of Cherrywood Trail; thence with the easterly side of Cherrywood Trail on a curve, the chord of which is S. 6-26 E. 70.98 feet to an iron pin at the point of beginning.
