ALL water mains, lines, valves and appurtenances installed and located at Asheton, Sec. II, off Asheton Way, in Greenville County, State of South Carolina, including 850 feet, more or less of 8" C. I. Pipe; 915 feet, more or less, of 6" D. I. Pipe; 880 feet, more or less, of 2" Galv. Pipe; four (4) 6" valves; four (4) 2" valves; two (2) fire hydrants; and eight (8) valve boxes as shown on a drawing entitled "Asheton, a S.C. General Partnership to Commissioners of Public Works of the City of Greenville, S.C.", dated June 2, 1983, attached hereto and made a part of this conveyance.
