release unto Frederick L. Faber and Debra N. Faber, their heirs and assigns,

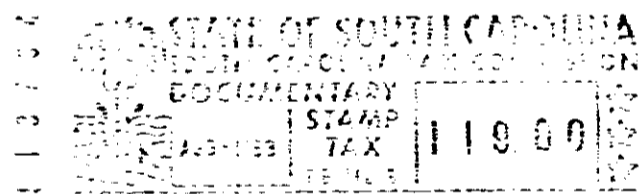
ALL that certain piece, parcel or lot of land, situate, lying and being in the State of
