the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto

WILLIAM L. LACHER, his heirs and assigns forever:

ALL that piece, parcel, or lot of land with the buildings and improvements thereon situate, lying, and being on the Easterly side of Townes Street, in the City and County of Greenville, State of South Carolina, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Easterly side of Townes Street at the Northwest corner of Walker (or formerly) property, said pin being 172 feet Northeast of the Northeast corner of the intersection of Townes Street with W. Park Avenue, and running thence along said Walker line, S. 77 E., 223 feet to an iron pin on the Westerly side of a twenty-foot alley; thence along the said line of the said alley, N. 13 E., 120 feet to an iron pin on the South line of Sloan (or formerly) property; thence along said Sloan line, N. 85 1/2 W., 224.5 feet to a stake on the Easterly side of Townes Street; thence along said Townes Street, S. 13 W., 86 feet to the POINT OF BEGINNING.
