Pipe; four (4) 6" valves; two (2) 2" valves; two (2) fire hydrants; and six (6) valve boxes as shown on a drawing entitled "American Service Corp. to Commissioners of Public Works of the City of Greenville, S.C.", dated August 31, 1983, attached hereto and made a part of this conveyance.

TOGETHER with all other mechanical parts and equipment appurtenant to the said lines and all rights-of-way and easements necessary or incident to the operation, maintenance, repair or replacement of said water lines and appurtenances.
