



(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Marcia J. Walker, her heirs and assigns, forever:

All that piece, parcel or lot of land situate, lying and being on the Northern side of Stanley Drive, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Unit No. 19 on plat of Harbor Town, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 5-P at pages 13 and 14, and being more particularly described as follows:

The within conveyance is subject to such restrictions, setback lines, zoning ordinances, utility easements and rights of way, if any, as may affect the above described property.

The Grantee herein assumes and agrees to pay the balance due on that certain mortgage in the original principal sum of \$25,800.00, given by Eugenia Wellborn Irwin to Mid-South Mortgage Company, Inc., dated September 24, 1976, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Mortgage Book 1378 at page 664. This mortgage was subsequently assigned by Mid-South Mortgage Company, Inc., to Walt Whitman Federal Savings & Loan Association (now by merger First Nationwide), by assignment dated September 27, 1976, and recorded in said R.M.C. Office in Mortgage Book 1378 at page 668. The principal balance due on this mortgage being \$24,147.94.
