3. Grantor hereby warrants the validity and effect of the rights of way assigned herein and agrees to indemnify and hold harmless Grantee, its agents, and employees against any and all claims or damages that may result from any legal defect in such rights of way. Upon written notice of such claim or defect to the chief administrative officer of the City, Grantor shall correct same within a reasonable period of time. Grantor shall in no way be liable or responsible for acts or omissions of Grantee, its agents, or assigns.

4. All of its rights, title and interest in a sanitary sewer trunk line in the Overbrook-Lowndes Hill Road area built in 1954 as shown on City of Greenville Engineering Department's drawings File No. 11-10 Sheets 1, 2, 3, and 4 dated 8-31-54, as modified and relocated by the South Carolina Department of Highways and Public Transportation as shown on drawings dated 4-1-50 on South Carolina Highway Department Engineering Drawings for Greenville County, Docket No. 23,436.1 Sheet Nos. 24, 25, and 26 to accommodate the construction of Interstate 385; together with all of its right, title and interest in whatever form acquired, be it by recorded right of way or easement, by recorded plat or other public record, or by prescription, to the right of way acquired for the installation and maintenance of this sanitary sewer line in 1954. Grantor hereby certifies that this sewer line was designed and installed in 1954 and has been continuously maintained by the City of Greenville since that date, and agrees to indemnify and hold harmless the grantee, its agents and employees against any and all claims or damages that may result from any defect in such rights of way. Upon written notice of such claim or defect to the Chief Administrative Officer of the City, grantor shall correct same within a reasonable period of time.
