State of South Carolina This Indenture Made this fiftenth Day of August One thousand seven hundred and Eighty seven, Between Abner Bishop of Ninety Six District and Greenville County of the One part and Daniel Ford of the same Place of the Other part Witnesseth, that the said Abner Bishop for and in consideration of the sum of Ten Shillings Sterling money of the State aforesaid to him in Hand paid at and before the sealing and Delivering of these Presents The Receipt whereof he doth hereby acknowledge, hath Granted Bargained, Sold and Aliened Remised, Released, and confirmed unto the said Daniel Ford in his Actual Possession now being by virtue of a bargain and sale to him thereof made for One whole year, by Indenture of Lease bearing date next the day next before the day of the date Hereof and by virtue and force of the Statute for Transferring of uses into Possession and to his heirs and assigns all that part of a Tract of land containing Three Hundred and Thirty Acres Situate Lying and

Being in Greenville County on both sides the Ready fork of Ready River nine and Six District bounded by Mary Burns land and Co. Morris land Granted to Abner Bishop by the States Letter patent, under the hand of William Moultrie Esquire the then Governor. Bearing date the fifth day of June 1785 and hath such shape form and marks as the plat thereof Directs to the Original Grant annexed. Together with all and singular that part of said Tract containing by Estimation One hundred and sixty five acres be the same more or less. Beginning on a Black Oak on a line of the said tract from thence S E 60° along the said line to the corner a stake, from thence N E 20° 20 chains 50 links to a red oak corner from thence N W 60° 22 1/2 to a post oak corner. thence N E 30° 42 chains to the corner a sourwood, thence N W 60° along this line to a post oak corner agreed on from thence along a line of marked trees to the beginning. The Ways, Wells, Waters, Water Courses, Easements, Profits, Commodities, Advantages, Emoluments, Hereditaments and Appertinances, whatsoever to the said land belonging or anywise Appertaining and the Reversion, and Reversions, Remainder and Remainders, Rents, Issues, and profits thereof and also all the Estate, Right, Title, Interest, Possession, Property, Claim and Demand whatsoever either in law or Equity of the said Abner Bishop of into or out, of the said Premises To have and to hold the said tract of land be the same more or less hereby Granted and Released with their Appertinances unto the said Daniel Ford his heirs and assigns forever, and the said Abner Bishop for himself his heirs and assigns do Covenant & Grant and agree to and with the said Daniel Ford his heirs and assigns By these Presents that it shall and may be Lawfull to and for the said Daniel Ford his heirs and assigns at any time hereafter to Enter into hold Occupy, Possess and Enjoy, the said land and premises without any Let, Suit, Trouble, Molestation, Interruption of the said Abner Bishop and his heirs or any of them or any other person or persons Lawfully Claiming or to claim by from or under him or any of them and also that the said Abner Bishop and his heirs shall and will from time to time and at all times hereafter at the Reasonable Request and proper Charges of the said Daniel Ford his heirs and assigns Make do Acknowledge Execute or cause to be made done and Acknowledged and Executed all such further and other Lawfull and Reasonable Acts Conveyances and assurances in the law whatsoever for the better and more perfect Conveyance and Assuring the said Tract of Land and premises unto the said
