49 South Carolina Greenville County May the Nineteenth One Thousand Seven Hundred and Eighty nine, A Deed of Conveyance for two Hundred and Seventy four acres of land from Edward Ballinger to Henry Machin acknowledged in open court by the said Edward Ballinger and ordered to be recorded.

This Indenture made the nineteenth day of May in the year of our Lord one Thousand Seven Hundred and Eighty nine, and of the Independence of the united States of North America the thirtieth; Between Edward Ballinger of Greenville County and State of South Carolina of the one part, and Henry Machin of the County and State aforesaid of the other part, Witnesseth that the said Edward Ballinger for and in consideration of the sum of two hundred pounds Sterling to him the said Edward Ballinger in hand paid by the said Henry Machin there receipt whereof the said Edward Ballinger doth hereby acknowledge, he the said Edward Ballinger hath granted, bargained, and sold, aliened and confirmed, and by these presents doth grant, bargain and sell, alien and confirm unto the said Henry Machin his heirs and assigns forever, a certain tract or parcel of land containing by computation two hundred and and Seventy four acres (or the some more or less) situate in the county aforesaid on both sides of Enoree River, beginning on a Red oak the original corner and running thence N E 50° acros Enoree River Eighty chains to a Red oak the original corner, thence N W 82° 15' twenty eight chains to a Red oak on the original line, thence S W 50° ten chains to a hickory, thence N W 82° fifteen chains to a stake, thence S W 50° fifty five chains acros Enoree River to a stake on the original line, thence with the
